## MINUTES OF THE ADVISORY COUNCIL MEETING

MARCH 5, 1938

Meeting of the Advisory Council held at the call of President Erb  
March 5, 1938.

Present: Dr. Donald M. Erb, President, Dr. James H. Gilbert, Vice-  
chairman, Dean Wayne L. Morse, Professors O. J. Hollis, O.K.  
Burrell, and S. S. Smith. Absent: Dean George Rebec.

The President presented to the Council a general statement of the  
problem of annuities in connection with some of the older members  
of the Faculty who plan to retire within a short period. The particular  
problem presented was that of a member of the Faculty who will reach the  
retirement age in July, 1938. Under the ruling of the Board, this indi-  
vidual is permitted to finish the school year 1938-39. However, this  
does not exactly conform to the regulations of the Carnegie Corporation.

The President explained that a plan had been presented whereby this  
individual would retire and accept the annuity in June, 1938, and be  
reappointed to the University staff for a one-year period beginning  
September, 1938. It was explained that only by this method could the  
family of the individual in question be protected during the extra  
year of teaching. The Council advised the President that in its  
judgment the assent of the Carnegie Corporation should be obtained  
prior to the reappointment of this individual, in order to insure  
that the family would be fully protected.

The President also presented to the Council a statement of the conflict  
of views in the German Department. He read a letter addressed to the  
President from Dr. Schmidt, Head of the Department. It was the general  
opinion of the Council that the President should act in this matter  
only upon the definite recommendation of the Dean of the School of Arts  
and Letters, and that the matter should be referred to Dean Boyer for a  
specific recommendation before further action.

The President presented several budget matters for the consideration  
of the Council. These matters were largely based on special situations  
and represent recommendations not previously acted upon by the Council.

1. It was recommended that Associate Professor F. A. Cuthbert be  
placed on a ten-month tenure basis rather than a twelve-month  
tenure basis. This does not involve a change in salary.

It is to be remembered that the Council, in connection with  
its recommendations on the Architecture and Allied Arts budget,  
recommended that the time of Professor Cuthbert now taken up at  
the College be transferred to the University. It was agreed  
that the recommendation for ten-month tenure would be approved  
by the Council.

2. An increase in salary for D. J. McCosh, Instructor in Archi-  
tecture and Allied Arts, from \$2,380.95 to \$2,480.95.

The President reported this increase in salary was included in the regular budget of the School of Architecture and Allied Arts and that the funds had been provided by a transfer of \$100 from the requisition account of this School.

In view of the request for an increase in the requisition account, the Council could not approve the request for the increase in salary on the basis of such a transfer. The Council did approve, however, the inclusion of this increase of \$100 in salary and a change in rank from Instructor to Assistant Professor as an item in the supplementary budget.

**3. Indefinite tenure for Dr. Marian G. Hayes.**

This item, not previously presented for the consideration of the Council, was approved.

**4. Increase in salary for Dr. L. A. Wood, Professor of Economics, from \$3,000 to \$3,200.**

The President stated that both he and Dean Gilbert were unanimous in urging this increase in salary, and it was approved by the Council.

**MINUTES OF THE ADVISORY COUNCIL MEETING**

**MARCH 14, 1938.**

**Present:** Dr. Donald M. Erb, President, Dr. James H. Gilbert, Vice-chairman, Dean George Rebec, Professors O. K. Burrell, O. J. Hollis and S. S. Smith. **Absent:** Dean Wayne L. Morse.

The Council met at the call of the President for the purpose of discussing and reviewing the regular budgets presented by the various deans and department heads. There was a general discussion of the procedure which the Council should follow in the consideration of these regular budgets. It was agreed that it would be sufficient to examine only significant changes and shifts within these regular budgets.

The President presented the significant changes in these regular budgets, and the Council made recommendations as follows:

1. The proposal to increase the requisition budget of the School of Journalism by \$129.69, out of savings in other sections of the general University budget.

This is, in part, a bookkeeping transaction. This amount was transferred from the current budget of the School of Journalism to cover an overdraft last year, and this is in the nature, only, of a restoration of the Journalism budget to its previous status.

- 2. R. W. Leighton, advanced from Acting Dean to Dean.

The question of salary was also discussed. Dean Leighton's salary at present is \$4,500 against the established minimum of \$4,725 for the rank. The Council decided to recommend against a salary change until such time as adjustment of salary to rank in the lower salary brackets and ranks can be made.

- 3. F. R. Sipe, change from yearly tenure to indefinite tenure.
- 4. A. L. Alderman, Assistant Professor, change from yearly tenure to indefinite tenure.
- 5. H. S. Hoyman, recommended for indefinite tenure, subject to the approval of the Dean of the School of Physical Education.

The proposal to allow Mr. Hoyman a sabbatical year on half pay was also approved with the understanding that Mr. Hoyman's work would be provided for without an increase in the budget.

- 6. Ruth Chilcote, change from monthly tenure to yearly tenure.
- 7. The Council approved a sabbatical leave on full pay for Dr. Warren D. Smith for the winter term 1938-39, with the understanding that Dr. Smith would, himself, defray the costs incident to carrying his work on the campus during the winter term.

- 8. The Council approved the proposal of the Dean of the College of Social Science to make Professor H. G. Townsend Head of the Department of Philosophy.

- 9. The Council approved the provision for local travel for Mrs. Anne Landsbury Beck, in the amount of \$200, out of the requisition budget of the School of Music.

This local travel represents transportation of practice teachers to the various Eugene schools. The Council had previously disapproved an increase in the salary of Mrs. Beck to cover this expense.

- 10. A portion of the salary of John Stehn is, at present, being carried by the Educational Activities Board. The Council approved the proposal that the State Board of Higher Education be asked to carry the full salary of Mr. Stehn, as is done in the case of the band leader at Oregon State College.

- 11. The regular budget of the Department of Sociology contemplated the replacement of two teaching fellows receiving, respectively, \$1,000 and \$750 per year, with an assistant professor at \$2,000 per year.



This proposal does not involve an increase in the Sociology budget for next year, due to the fact that this salary would not begin until October 1. However, it does involve an increase of \$250 in the going rate of the Sociology Department.

The Council approved the replacement of the two teaching fellows with an instructor at \$2,000. The Council was unwilling to recommend the appointment of an assistant professor on the ground that the salary contemplated was under the recommended minimum for an assistant professor.

12. It will be remembered that the Council had recommended against the inclusion of the third secretary in the School of Physical Education budget. The President reported that the third secretary had been included in the regular budget of the School of Physical Education.

The Council discussed this matter at some length, and unanimously reaffirmed its previous position in the matter.

13. The President reported that George Godfrey, of the University News Bureau, was to return to full-time service beginning July 1, and asked the Council for its recommendation on the matter of salary. It will be remembered that last year Mr. Godfrey's salary was increased from \$3,000 to \$3,600 on the basis of his connection with the State Planning Board and on the definite statement that the old salary rate would be restored when Mr. Godfrey came back to the University full-time.

The Council unanimously renewed its recommendation of last year, that Mr. Godfrey's salary be restored to the previous level of \$3,000. The Council asked the President to discuss this matter with the Chancellor and to advise him of the position of the Council.

The Council was advised that there were net savings aggregating some \$1,600 in the regular University budget exclusive of any savings involved in the elimination of the third secretary in the School of Physical Education. The Council agreed that the net savings should be applied to the most meritorious items in the supplementary budget requests. It was the general understanding that at a later meeting the Council would be asked to make recommendations regarding the application of these savings.

Dean Gilbert reported that a few additional supplementary budget requests had come to him, and that he would present these requests to the Council at a meeting to be called at an early date.

The Secretary presented the following letter from Dean Morse:

It was recommended that a full-time instructor in Mathematics be provided to replace the present half-time instructor, necessitating an increase in the 1938-39 budget of . . . . . 750.00

The President reported on various matters relating to the budget, particularly to the budget savings of \$1,611.06 about which recommendations were made in the meeting of March 29, 1938. The President reported that it was not entirely certain that this saving could be applied, under the rules of the Chancellor's office, to salary increases as recommended by the Council. He advised the Council that under the rules of the Chancellor's office it might be necessary to apply at least a portion of this saving to the retirement pay of Dean Rebec because Dean Rebec's annuity was inadequate to provide half salary.

The Secretary reported the following communication from Dean Wayne L. Morse:

"Washington, D.C., April 1, 1938.

"Dean James H. Gilbert

"Dear Dean Gilbert: Thank you very much for sending me the copy of the supplementary budget report of the Advisory Council. Inasmuch as I am still a member of the Council I wish to cast my votes in regard to the requests of Dean Boyer and Dr. Morris.

I believe that I am familiar with the facts concerning each one of the items.

"(1) Recommendation for part time secretary in speech,  
\$360 Yes.

"(2) Recommendation for increase \$150 in salary of Mr.  
John C. McCloskey Yes.

"(3) Recommendation of increase \$262.50 for S. Stephen-  
son Smith \* \* \* \* \* Yes.

"(4) Recommendation of increase in salary for Lowell B.  
Ellis, \$75.85 Yes.

"(5) I strongly favor urging Dr. Boyer to make the necessary adjustments and savings in the English budget so as to bring George Williamson back at a salary of \$3,700 if his services can be obtained at that salary. My study of the University budget, including that of Dr. Boyer's division, convinces me that Dr. Boyer could make the necessary savings that would enable him to bring Dr. Williamson back to the University at a salary of \$3,700. Personally I think the Advisory Council should reconsider its recommendation in regard to Dr. Williamson. I think one of the most important educational needs at the University of Oregon right now is to strengthen our graduate work. Certainly we should look to our College of Letters and Arts to take the lead in that direction. It seems to me that an English Department as large and well staffed as the English Department at the University of Oregon should be expected to offer a very good graduate course of study leading to a Ph.D. degree.

"Before I left Oregon, I took it upon myself to interview several members of the English Department relative to the Williamson case and I also talked to several members of the Faculty who are very well informed as to graduate school problems as they exist at Oregon. As a result of that investigation, I am convinced that from a standpoint of scholarship and research Williamson should be returned to the campus if it can be done for a salary as low as \$3,700 as suggested by Dr. Boyer.

"Even though the other members of the Council do not agree with me in regard to the Williamson case, I shall appreciate it very much if the secretary will submit my point of view and vote on the matter to President Erb.

"(6) I concur in the recommendation of the Council that Dean Morris' request for a \$200 increase in the salary of Dr. Bond should not be granted at this time.

"(7) I concur in the decision of the Council that the Council's decision in opposition to the proposed appointment of Dr. Jessup to the staff of the Philosophy Department should not be modified. \* \* \* \* \*

"I shall appreciate it very much if my decisions in regard to the above matters will be recorded in the Council's minutes.

Dr. Erb inquired concerning the practice of the of the Advisory Committee in making recommendations regarding the membership of faculty committees. Professor Ernst had wished to know whether he would be reappointed as chairman of the Lectures Committee, in order that he might know what to do in regard to tentative plans for next year's program. The Council was of the opinion that it would be impossible to make a final selection of any committee until the whole subject is canvassed, but that Professor Ernst should go ahead with all necessary plans.

The President reported that the question of the status of George Godfrey and George Bellmap with respect to voting privileges at faculty meetings had been raised again. It was indicated that to reopen these two cases would involve a reconsideration of the entire subject of the status of non-teaching staff members with academic rank. After a brief discussion the Council adjourned.

Professor Jameson was present and discussed his case with the Council. Dr. Jameson was advised that the request for an increase in salary for him had been approved by the Head of his Department, the Dean of his school, the Advisory Council and the President, and had been transmitted to the Chancellor and to the Board. The Council further advised Dr. Jameson that, in its opinion, little could be accomplished at the present time by making an issue of the case. The Council assured Dr. Jameson that, in its opinion, an injustice had been done him, but that the case had been carried to the highest court available to us and that no sufficient basis for further present action seemed indicated.

The Council, however, agreed that the President should secure whatever additional information might be available concerning the disposition of this case and the reasons therefor.
