Information collected with the Sugai-Tobin Archival Review (STAR)

- (a) Attendance
- (b) Grade retention
- (c) School transfers
- (d) Academic performance
- (e) Special education

- f) Office discipline referrals,
- g) Functional behavior assessments
- h) Behavior support plans

Reliability: 95.71%

• Inter-observer reliability was assessed for 23% of the students by having two trained data collectors independently complete the STAR.

• (Agreement / (Agreement + Disagreement)) * 100.

• The mean overall agreement was 95.71% with category agreement ranging from 88.7% to 100%.

- ➤ 209 students from 17 schools in 9 districts in Oregon
- ➤ Males out-numbered females, 4 to 1 in both groups.
- ➤ On average, 14 or 15 years old at the time of the exclusion.
- Ss with disabilities were disproportionately suspended and expelled from high school

"IN" Group (n = 64, 31%)


- Placement changed instead of expulsion
- Hearing officer ruled against expulsion
- Expulsions waived

"OUT" Group (n = 145, 69%)

All other students whom the school had identified as having been sent to an expulsion hearing and expelled.

Note: Average SPED population in all 9 districts was 14%



Students in the "OUT group" tended to have a history of


Office discipline referrals,
Suspensions,
Poorer attendance and grades as they got older.

Overall Findings

- Marijuana is the most frequent reason for expulsions
- Escalation in frequency of ODRs (especially non violent) at the middle school level
- Schools with Zero Tolerance policies were most likely to waive expulsions and return some students to school "on probation."
